The conference, in connection with the Partnership for Lifelong Learning of the European Union, has the general objective to foster social integration of people from different religions through intercultural and interfaith cooperation in the field of care and counselling in Europe. The conference will focus on socio-political aspects of spiritual care. In June 2015, the questions of integration and inclusion in care and counselling will be further discussed during the SIPCC International Seminar in Wrocław under the theme:

Peacemaking and community building Religious sources of intercultural and interfaith cooperation.

Spiritual and religious aspects will be given special attention in the International Seminar.

It is becoming more and more important to get to know each other and to learn a respectful and dignified attitude towards other people, especially representatives of cultural and religious minorities. Therefore, the exchange between Muslims, Jews, Christians, people without religious affiliations and atheists from different countries is of great importance and constitutes an added value in the European context.

Integration and coexistence should be encouraged throughout the EU Lifelong Learning Partnership project, and in this conference through exchange and the development of educational models for intercultural and interfaith care and counselling. These models are formulated to be applied against xenophobia and discrimination of people because of their gender, race, ethnicity, religion or belief and to deal with societal problems. The main focus will be on the appreciation of strangers and mutual assistance in coping with life's problems.

At the end of the conference and the entire project for Lifelong Learning "Models of inclusive education in intercultural and interreligiouis care for Europe" should be developed to promote the education, training and further education of people, from all walks of life, who wish to work or volunteer in caring and counselling. Especially young adults, seniors and people with low professional qualifications should learn how to approach "others" in a helpful way.

Target group:

60 people from different European countries who are involved in the practice and teaching of care and counselling.

The conference will be conducted in Polish, German and English.





Conference methodology and process

Models of inclusive education in intercultural and interreligious care and counselling for Europe

The focus of the conference will be working in six fixed groups (about 10 people each). Seven 90-minute sessions are planned for this purpose. In each, three people from different countries will give practical reports from the following areas of care and counselling:

Congregation and communityHospitalSchool

- Homes – Work with migrants

The practice of care and counselling in these fields of work and the respective social contexts will be presented. Intercultural and interreligious questions will be given special consideration. Apart from the presenters, other persons working in these fields and also experts in education will reflect on the presented practice and jointly formulate models.

One should note that intercultural and interfaith education continuously has to deal with tensions between differences and similarities among different cultures and religions. Such tensions should be noticed and one should consider how they can be addressed in the models.

We start out from the assumption that care and counselling services by volunteers is done through an officially recognized institution, is learned in groups, and that the practice should be reflected in groups (supervision). Therefore, the educational models should address training and support in groups.

Practice reports

The following issues should be described:

- 1) What is the social, political and institutional context of the practice?
- 2) What is the cultural and religious context?
- 3) Which needs (especially pschological, cultural and religious) do the people in the respective context have?
- 4) What is already being done to address the needs of the people? (Are there already caring and counselling activities? If yes, how are they conducted? Are there people providing such activities? How are they trained to do care and counselling)
- 5) What could volunteers in care and counselling offer to meeting the needs of the people?

The practice reports should include elementary issues, be written in an way that is easy to understand, and emphasize personal involvement.

The practice reports must be submitted before the conference as essays (about 5-6 pages), so that they can be used to formulate models. The presenters are asked to submit them before **15 January 2015** so that they can be translated, sent to the participants and read.

The draft of integrativ educational models

During the presentations and reflections is considered which of the following points could become important and helpful for the needs of the people in the described field work and could be supported by the implementation of an educational model.





The following qualities of th people should be supported:

- 1) Independence, integration and group formation How can care and counselling help people to find their place in a group (care seekers and counsellors)?
- 2) Strengthening of the personality How can communication and relationship skills be developed?
- 3) Participation in social activities
 How can social, cultural and religious commitment be lived and promoted?

In a next step there is the aim to find substantial and organizational concretions:

- 1) The institutional context In what integrative institutional context could care and counselling of volunteers be made?
- 2) People for affering care and counselling people for the training of volunteers How can volunteers and teachers be recruited?
- 3) Qualification for integrative counseling work How can volunteers be found and trained?

For each of the six areas of work, a written version should be available at the end. The models should be used in practice, so they should be formulated accordingly. These should be projects with sustainable, inclusive and practicable results.

Throughout the conference, the members of the working groups stay together. Each working group will be accompanied by a moderator. If needed, *dr Dominiek Lootens* offer assistance during working group sessions.

The conference will be conducted in Polish, German and English. Each working groups will have two languages (if possible only one). Qualified interpreters will be present.

Procedure in individual working group sessions

The purpose of first working group session is to get to know each other, clarify expectations and how the work in the group can be done together.

Sessions 2 - 7 involve the following steps: Presentations and reflection in the one session, in the next a draft of models is sketched, which in the course of the conference will be enriched, and written down in a paper at the end.

Presentation and reflection (90 minutes)

The presentation, which has been submitted in writing and read by the participants, is summarized during the session and verbally explained based on a PowerPoint presentation or other means. At this point, the most important issues of the practice of care and counselling in this special situation are highlighted (20 - 30 minutes).





After the presentation and clarification of understanding, reflection on the above-mentioned issues starts: The education experts write down keywords from the presentation that are relevant for the discussion on the draft of educational models.

Formulation of models

After every session of presentation and reflection, the group works together to formulate models for the respective area of work. Then, it is checked whether the presentation and discussion includes elements, which could be transferred to other contexts (countries or social conditions). At the end, presentations and notes from the discussion are combined to form "Models of inclusive education in intercultural and interreligious care for Europe." In each group, there will be people who teach in different areas of care and counselling (especially in adult education) and can formulate educational concepts.

If possible, at the end of the conference, participants should look for models that are relevant across various areas of work.
